The columns were found to have surface rust, therefore have been returned for re-surfacing.

ISIP - Funding for property works will be extended to state integrated schools via Diocese. Schools will be assigned a property manager to authorise expenses. OLSOS will plan to have a "wish list" prepared with supporting quotes.

CAPITAL WORKS ACCOUNT - to be reinstated as a way to have provision funds for the maintenance of school owned property (such as the COLA and school hall at 44%).
