Special Business

2.1 NZEI Te Riu Roa presentation

Presented by Detta Fairweather, Lee Marten, Heather Collins, Tracey Elder, Helen Burger and Alice Shin.

The Primary Teachers Collective Agreement is up for renegotiation. This time NZEI Te Riu Roa is focusing on conditions of service, mainly staffing concerns.

The Government is being asked by primary schools to:

- 1. Have a staffing allocation commensurate with secondary schools. Secondary schools have 20 -30% more staffing compared to primary schools.
- 2. Progressively increase classroom release time to one day per week for full-time teachers.
- 3. Increase the funding for Learning Support

The ultimate aim is to focus on better outcomes for students.

Members agreed to support the concept via posters around the school so community understands initiatives/outcomes. Facebook/Newsletters also avenues for communication.

In order to minimise disruption for students, leadership will supervise students whilst all staff attends the same union meeting.
