# 2. Principal and Management Reports

## 2.1 Principal's Report

Louise presented her Principals' Report for the month.

Highlights include:

- PLD across the school with Christine Braid from Massey University in delivery of a
  Structured approach to Literacy. This is part of the ongoing delivery of PLD in this updated
  pedagogy rolling out school wide. Detta recently won 250 hours of MOE funded PLD in the
  structured approach to literacy which we will utilise of 18 months starting in Term 4 to help
  support this journey. Recognition to Detta for her hard work in putting together this
  application.
- Update on Property projects.
- Stations of the Cross walkway is complete, bark be put down and planting to be done.
- Covid update and attendance update.
- Community Dreaming Day Louise expressed thanks to both Board members and staff
  involved in preparation and delivery of the day. Summary document is being prepared;
  There will be a community consultation until end of October for those who were not present
  to add their own thoughts.

#### Resilience Survey

Position paper presented to the Board by Louise. The purpose of this document is to seek the permission of each respective Board of Trustees (of our South East Christian Kāhui Ako "SECKA" member schools) to survey the student population using the Student Resilience Survey ("SRS").

- SECKA is currently working through the process of refreshing our Memorandum of Understanding with the Ministry of Education ("MOE"). This refresh will report the progress made on original achievement challenges and will propose new challenges to work on over the next few years.
- The voice of the combined community is that resilience is very important and needs to be worked on.
- In order to formally establish 'the fostering of resilience' as a future achievement challenge,
  the MOE requires more specific data be collected to gain a clearer picture of where our
  student population sits with respect to their resilience both socially and academically. For
  this reason the Across School Teacher team proposes that a student survey be carried in
  Term 4, 2022. It is proposed that a British survey, the Student Resilience Survey, is used
  to shed light on 'resilience levels' in our student population.
- The position paper outlines various ethical concerns and mitigating factors. The paper also outlines the specific questions asked.
- Data collected will be anonyms; students have the choice to 'opt out' of participating. Students in years 4 -6 will be surveyed.
- The Board needs to agree the SRS to be used to gather baseline data.
- The Board held a constructive conversation around the survey; agree that it leads to a, growth mindset, positive learning behaviour. Aligns to Community Dreaming day around understands where students are at.
