- Upgrade of Mud Kitchen see below for more details.

#### Upgrade of Mud Kitchen

The Finance Committee has raised the upgrade of the Mud Kitchen for the Boards' endorsement.

Currently there is a 2020 design to refresh the area with a quote provided at the time by the supplier.

The business has been sold in the intervening time; a new quote and some design changes have been proposed. The additional expense is \$31k, bringing to a total of \$96k for the refreshment of the area. The price increase is a mix of different factors including new design, increase in cost of labor and materials.

The area is located by the "Loose parts area". Learning dispositions associated area: sharing, problem solving, innovation, negotiation, collaboration.

The new design is to extend the use of the space to put a stage going to astroturf, outdoor classroom, sitting around the mound, development of an outdoor learning space which has a "Campfire" feel to it. The new design will allow for provision for water to be deployed to the area in a better way than the existing.

Members had a question regarding warranty - Louise to report back. Louise reminded members that this will be a legacy Board project (like the COLA), for which the maintenance of will come out of the Proprietors' fund.

Work will take 8 weeks and will be done over the Dec 22/Jan 23 school holidays.
