### 2.1 Board Professional Development

Board members welcome Mr Philip Mahoney, Manager - Catholic Education Services for the Catholic Diocese of Auckland.

Philip attended the June Board meeting to deliver PLD for members.

#### For discussion:

- Funding "Policy 2" funding, can be applied for (none recently), covers 80% of construction costs from floor up. Otherwise schools are funded via attendance dues, taking on debt, bequeaths etc.
- Maintaining existing buildings Each student is assigned dollars in terms of funding ("Policy 1" funding). approximately \$1,000 per student. Policy 1 funds are pooled to a common fund (52 schools), everyone gets a share over time depending on needs for use on major upgrades, new roof, operational grant for minor maintenance.
- Governance & Management (and the difference between the two). Clarity of role, procedures & policies, Principal knows what to do - the Board's key partnerships, processes and systems required to support students to achieve their potential.
- Look at how incorporating the Catholic world view/perspective to ensure there is integration to curriculum, not just in RE.

### Highlights included:

 Presentation and discussion on analysis of number of families versus the number of students at OLSOS over the past 8 years. Findings that whilst OLSOS has more families than ever before attending the school, there are less children (smaller family sizes) and subsequent impact on roll numbers.
