Introducing Our School Board

As we begin our new Board term, we are pleased to share with you a little more about the role of the Board of Trustees at Our Lady Star of the Sea, introduce our members, and explain how we work together to support our children, staff, and community.

The Role of the Board

Our School Board works in partnership with the principal and staff to ensure that every child has the best opportunity to succeed. We are responsible for governance of the school, setting its strategic direction, ensuring financial stewardship, maintaining a safe and supportive environment, and upholding the Catholic character that is at the heart of all we do.

The Board meets monthly during term time, receiving reports from the Principal and subcommittees. These reports provide assurance that the school is working towards its strategic goals, meeting legal and financial obligations, and maintaining a safe and supportive environment for our Tamariki and staff.

How We Are Reviewed

To ensure we remain accountable and focused on continuous improvement, our work as a Board is regularly reviewed:

Catholic Special Character Review – conducted by the Diocese every three years, to ensure the Catholic faith remains at the centre of our teaching and school life.

Annual Finance Audit – carried out each year by the Office of the Auditor-General, ensuring strong financial stewardship and transparency.

Education Review – held approximately every three years, with the Board responding to recommendations from the Education Review Office (ERO).

Strategic Planning – every three years we engage with our community to help shape our school's Strategic Plan, which sets the vision and priorities for the future. The Board then receives regular reports each term to monitor progress against these goals.

Our Board Members

This year, our Board is made up of:

Four Proprietors' Representatives – appointed to safeguard Catholic special character and ensure it is upheld across all aspects of school life.

Five Parent Representatives – elected by our parent community to bring a family and community voice to the table.

One Teacher Representative – elected by our teaching staff to ensure the professional perspective of the classroom is part of every discussion.

The Principal – both a Board member and the educational leader of the school, ensuring the vision of our school is carried out day to day.
